We treat all information submitted through the contact form as **confidential**. This includes personal stories, health concerns, or other sensitive information.

We apply **NDA-style confidentiality principles** to all communications. Your data will never be shared without your explicit permission, unless required by law.

### 5. Legal Bases for Processing

Under the GDPR, we process your data under the following legal bases:
